PROJECT DESCRIPTION

The project will include 15.49 km of asphalt concrete resurfacing on the eastbound lanes of Highway 16 from 180 m east of the Lashburn access to the Marshall access; for a total distance of 15.49 km.

PROJECT DETAILS

- The Contract Number for this project is H25065.
- The Contractor for this project is HJR Asphalt Inc.
- The Contractor's address as indicated on the bidder's signing block is Saskatoon, SK.
- Contract supervision will be provided by Integrated Engineering Inc. personnel.
- The contractor will carry out the work in two phases. Phase I will involve the installation of nine culverts by boring at various locations between Marshall and Lashburn, with work scheduled to begin the week of September 1, 2025. Phase II includes resurfacing the eastbound lanes of Highway 16 from Marshall to Lashburn and is expected to commence the week of September 29, 2025. The anticipated completion date for the entire project is October 31, 2025.
- The public can expect traffic accommodation at the construction zone, including Electronic Variable Message Boards, portable rumble strips, automated speed enforcement signs, speed reductions, one-lane traffic and radar speed feedback signs.
- The estimated total cost of this project is \$6.6 million, including materials, construction engineering, and PST.
- This is a Capital Program project in the Central Maintenance Region.
