BYLAW NO. 6-2012

A BYLAW TO REGULATE THE SPEED OF MOTOR VEHICLES

The Council of the Rural Municipality of the Rural Municipality of Eldon No. 471 in the Province of Saskatchewan enacts as follows:

1. In this bylaw:
 - a) "municipal road" means a public highway or municipally owned roadway that is under the direction, management and control of the municipality;
 - b) "public highway" means a road allowance or a road, street or lane vested in or owned by the province including anything erected on or in connection with the public highway;
 - c) "provincial highway" means a public highway or a proposed public highway under the direction, management and control of the Department of Highways and Transportation: and
 - d) "roadway" means that part of a public highway designed or intended for use by vehicles but does not include a trail designated under *The Snowmobile Act* or any other trail or path for which a permit is required;
2. No person shall operate a motor vehicle at a greater speed than 90 kilometers per hour on the municipal roads described as follows:
 - That portion of Primary Grid # 684 located East of Sections 5, 8, 17, 20, 29 & 32 48-24-W3, East of Sections 5, 8 & 17 49-24-W3, through Section 20 and East of Pt. NE 19 and East of Sections 30 & 31 49-24-W3, East of Sections 6, 7, 18, 19, 30 & 31 50-24-W3 & through NE 31 50-24-W3 and South of Sections 5 & 6 51-24-W3;
 - That portion of "Lashburn Battery Road" (Twp Rd 490) located North of Sections 33, 34, 35 & 36 48-24-W3 and North of Sections 31, 32 & 33 48-23-W3;
 - That portion of the "Silver Lake Road" (Twp Rd 492) located North of Section 10 49-23-W3;
 - That portion of "Old Highway No. 21" located North of Section 8 & 9 47-23-W3; and East of Section 16 & 21 47-23-W3;
 - That portion of the "Five Mile Road" (Twp Rd 484) located North of Section 22 48-23-W3;
 - That portion of the "Three Mile Road" (Twp Rd 482) located North of Sections 10 & 11 48-23-W3 and North of Section 12-48-23-W3;
 - That portion of the "One Mile Road" (Twp Rd 480) located North of Sections 34, 35 & 36 47-23-W3 and North of Section 31 47-22-W3;
 - That portion of Twp Rd 490 located North of Sections 31, 32, 33-48-22-W3;
 - That portion of the "Taylor Road" (Rge Rd 3230) located West of Sections 6,7,18 & 19-48-22-W3.
3. Signs indicating the maximum speed of 90 kilometers per hour shall be erected at the commencement of the speed zone area and signs shall be erected showing the end of the speed zone area.
4. Any person who contravenes any of the provisions of this bylaw is guilty of an offence and liable on summary conviction to the penalties provided in the general penalty bylaw of the municipality.
5. This bylaw comes into effect upon approval of The Highway Traffic Board.
6. Bylaw No. 6-2008 is hereby repealed.
